The abovementioned personnel shall conduct inspection of establishments/workplaces, investigation of work-related accidents, review the implementation of inspection programs and activities including validation/audit of inspection reports and procedures to determine compliance and/or deficiencies with the prescribed enforcement policies, rules and regulations.

Likewise, the abovementioned personnel may be nominated to constitute a Special Inspection Team (SIT) tasked to conduct other inspection related activities.

The concerned Regional Director shall issue the corresponding Authority to Inspect/Investigate to specific target establishments/workplaces. The said authority is co-terminous with the term of the General Authority which is until 31 December 2018, unless a shorter period is provided by the Regional Director.
